A RESOLUTION AMENDING AND SUBSTITUTING THE SETTING OF SALARIES AND WAGES FOR APPOINTED OFFICERS AND EMPLOYEES OF THE CITY OF LAURENS FOR THE FISCAL YEAR 2016-2017, BEGINNING JULY 1, 2016
