The Laurens City Council met in regular session at the Municipal Building at 5:00 pm, November 3, 2014. Mayor Rod Johnson called the meeting to order. Present were Council members Rich Newgard, Thaine Hopkins, Jean Swanson, Sid Enockson, and Julie Potter; City Manager, Barbara Smith; Sewer Supt, Pete Runneburg; and City Attorney, Ann Beneke.

Johnson indicated that Smith wished to rescind her resignation that had been presented to him on October 27, and that item #8, acceptance of City Manager resignation; and item #9, Update from City Manager search committee needed to be removed from the agenda. Enockson motioned to leave the items on the agenda and proceed. Enockson's motion died due to lack of a second. Swanson then motioned to amend the agenda removing items 8 & 9; seconded by Hopkins. Ayes—Swanson, Hopkins, Newgard, Potter. Ney—Enockson. Motion carried.

Newgard motioned to approve the consent agenda; consisting of the amended agenda, minutes from the October 20 meeting, and the list of claims; seconded by Swanson. Ayes all; motion carried.

Potter motioned to approve Resolution 41-14, appointment as school liaison; seconded by Swanson. Roll call vote: ayes all; motion carried.

Potter motioned to approve Resolution 42-14, banking signatures; seconded by Swanson. Roll call vote: ayes all; motion carried. Swanson motioned to approve renewal of health, dental, vision, AD & D, life insurances, as well as the long-term and short term disability; seconded by Hopkins. Ayes all; motion carried.

Swanson motioned to approve the REAP grant funds to construct the Prairie Park Trail in the amount of \$74,440; seconded by Potter. Ayes all; motion carried.

Newgard motioned to approve the Iowa Living Roadways funds to construct a rain garden in the ditch in front of the Fisher Building in the amount of \$12,451.00; seconded by Hopkins. Ayes all; motion carried.

Newgard motioned to hire Denetrius Washington, pending the results of the pre-employment drug screen, at a rate of \$10 per hour; seconded by Swanson. Ayes all; motion carried.

Hopkins indicated that he had completed the tour of City facilities lead by PWD Johnsen; Enockson voiced concern over communication between the city staff, mayor and city council; Potter has found someone to empty the County Recycling Trailer located in Laurens for the Pocahontas County Landfill Commission.

Runneburg indicated that the city has been televising the sewers in town. Smith stated that there were some areas that show damage due to the floods last June. We will apply for FEMA funding to repair these areas.

During citizens' opportunity for comment, Steve Berry indicated his concern about how the mayor was communicating with the council. Siepker reminded to everyone to vote on November 4.
